- 4. Details of the activities undertaken and services provided by the Monitor in connection with the monitoring of the Applicant are described in the Eleventh through Fourteenth Reports of the Monitor and any Supplemental Reports thereto.
- 5. In the course of performing its duties pursuant to the Initial Order, the Monitor has expended a total of 704.53 hours during the Period. #### Nelson Financial Group Ltd. Note to Summary of Monitor's Fees and Disbursements December 2010 – September 2011

- 1. Credit Note 5214 represents a discount to the Monitor's December 2010 billing agreed between the Monitor and the Interim Operating Officer (the "IOO") and Representative Counsel of Nelson in March 2011. The credit note reduces by 5.5 hours the time charged by the Monitor's staff. As a result of the Monitor giving this discount, the Monitor's December 2010 bill was "approved" by the IOO and Representative Counsel and was paid.
- 2. Credit Note 5215 represents a discount to the Monitor's January 2011 billing agreed between the Monitor and the IOO and Representative Counsel of Nelson in March 2011. The credit note reduces by 3.58 hours the time charged by the Monitor's staff. It also changes the billing rates being charged by the Monitor. The most significant agreed rate change was a reduction of the rate for Mr. John Page from \$425 per hour including in the January 2011 billing to \$407 per hour. The rates of other staff were increased by 10% but on the understanding that their ongoing time would be low. Mr. Page furthermore agreed to render further bills during 2011 at these adjusted rates. As a result of the Monitor giving this discount, the Monitor's January 2011 bill was "approved" by the IOO and Representative Counsel and was paid.
